### Respiratory protection

- ▶ Respirators may be necessary when engineering and administrative controls do not adequately prevent exposures.
- ▶ The decision to use respiratory protection should be based on professional judgment that takes into account toxicity information, exposure measurement data, and frequency and likelihood of the worker's exposure - ensure users are not subject to high thermal loads which may result in heat stress or distress due to personal protective equipment (powered, positive flow, full face apparatus may be an option).
- ▶ Published occupational exposure limits, where they exist, will assist in determining the adequacy of the selected respiratory protection. These may be government mandated or vendor recommended.
- ▶ Certified respirators will be useful for protecting workers from inhalation of particulates when properly selected and fit tested as part of a complete respiratory protection program.
- ▶ Use approved positive flow mask if significant quantities of dust becomes airborne.
- ▶ Try to avoid creating dust conditions.

## Information on toxicological effects

Inhaled	<p>The material can cause respiratory irritation in some persons. The body's response to such irritation can cause further lung damage. Persons with impaired respiratory function, airway diseases and conditions such as emphysema or chronic bronchitis, may incur further disability if excessive concentrations of particulate are inhaled.</p> <p>If prior damage to the circulatory or nervous systems has occurred or if kidney damage has been sustained, proper screenings should be conducted on individuals who may be exposed to further risk if handling and use of the material result in excessive exposures.</p>
Ingestion	<p>Ingestion may result in abdominal pain, nausea and diarrhoea. The acid is said to have been fatal after an oral dose of 12 gm, whereas the lethal dose for potassium bitartrate is about 100-200 gm. Deaths occurred between 12 hours and 9 days. Gastrointestinal symptoms were marked with violent vomiting, diarrhoea, abdominal pain and thirst preceding cardiovascular collapse and/or acute renal failure.</p> <p>Accidental ingestion of the material may be damaging to the health of the individual.</p> <p>Use as a food additive indicates good tolerance of small amounts, but excessive amounts or overuse may bring irritant and/or harmful effects</p> <p>Ingestion of low-molecular organic acid solutions may produce spontaneous haemorrhaging, production of blood clots, gastrointestinal damage and narrowing of the oesophagus and stomach entry.</p> <p>Salts of tartaric acid (including Rochelle salt and Seidlitz powder) and the acid itself have all produced serious poisonings or fatalities in man. Gastrointestinal symptoms are marked and include violent vomiting, diarrhoea, abdominal pain and thirst followed by cardiovascular collapse and/or kidney failure.</p>
Skin Contact	<p>This material can cause inflammation of the skin on contact in some persons.</p> <p>The material may accentuate any pre-existing dermatitis condition</p> <p>Skin contact is not thought to have harmful health effects (as classified under EC Directives); the material may still produce health damage following entry through wounds, lesions or abrasions.</p> <p>Open cuts, abraded or irritated skin should not be exposed to this material</p> <p>Entry into the blood-stream, through, for example, cuts, abrasions or lesions, may produce systemic injury with harmful effects. Examine the skin prior to the use of the material and ensure that any external damage is suitably protected.</p>
Eye	<p>If applied to the eyes, this material causes severe eye damage. Solutions of low-molecular weight organic acids cause pain and injury to the eyes.</p>
Chronic	<p>Long-term exposure to respiratory irritants may result in airways disease, involving difficulty breathing and related whole-body problems. Substance accumulation, in the human body, may occur and may cause some concern following repeated or long-term occupational exposure. Long term exposure to high dust concentrations may cause changes in lung function i.e. pneumoconiosis, caused by particles less than 0.5 micron penetrating and remaining in the lung.</p>

known as reactive airways dysfunction syndrome (RADS) which can occur after exposure to high levels of highly irritating compound. Main criteria for diagnosing RADS include the absence of previous airways disease in a non-atopic individual, with sudden onset of persistent asthma-like symptoms within minutes to hours of a documented exposure to the irritant. Other criteria for diagnosis of RADS include a reversible airflow pattern on lung function tests, moderate to severe bronchial hyperreactivity on methacholine challenge testing, and the lack of minimal lymphocytic inflammation, without eosinophilia.

For simple alpha-hydroxy carboxylic acids and their salts:  
Experimental data available for members of this group shows that they have low acute, repeat-dose, reproductive and developmental toxicity. They are eye and skin irritants, but are not expected to be skin sensitisers. Testing shows they have little or no potential to cause mutations or cancer.
